#### **Work Item 252779**

#### **Description**

Updated the Prospect/Student Import process.

- We added dropdowns for ACT Test and SAT Test selections to the Define Import Parameters page.
- After the import process has completed, we update the job run date in the CAMSImportGenericJob table. The records related to the import job are no longer deleted from the CAMSImportGeneric table.

#### **Description**

If the SAI on the ISIR in the ISIR detail page in Financial Aid > Maintenance > ISIR tab > detail was negative, the sign would flip on saving. This has been corrected.

On page 7 of the full ISIR report, the adjusted gross income for the student was not displaying the correct field. This has been corrected.

The default Enrollment Intensity will be 100% when the student has no courses registered in the term.
